1. Alcohol Beverage License - Sabores Mexico Bar & Grill

Sabores Mexico Bar & Grill, located at 3255 Lawrenceville Suwanee Road, Suite T, has applied for a new licensee to serve beer, wine, and distilled spirits. Ms. Johanna Sanchez is the licensee. The Business Services department recommends approval. Consideration of this item will be included on the November 14 regular agenda.

2. 2018 1st Quarter Event Schedule

To allow for needed planning time, regular recurring events planned for first quarter, 2018 are being presented for approval prior to the overall 2018 calendar. The entire calendar of events will be presented in January 2018.

3. Lawrenceville Suwanee Road Resurfacing Project

GaDOT has awarded a resurfacing contract to C. W. Matthews Contracting Co., Inc. for spring 2018. The project consists of 2.245 miles of resurfacing on Lawrenceville-Suwanee Road beginning at I-85 overpass bridge and extending south of Buford Hwy.

4. 2040 Comprehensive Plan

A draft of the final plan will be made available by the end of November for Council review. The draft is anticipated to be presented at the December 5 Planning Commission meeting.

5. Norfolk Southern Lease Amendment

Norfolk Southern Railway Company has proposed the first amendment since the lease agreement was executed in March, 2012. Consideration of this will be on the <u>November 14 consent agenda</u>, unless Council prefers otherwise.
