## A. Presentation: Town Center on Main Market Analysis

Over the last month or so a consulting team, Revel, has been studying options for the hilltop plaza area within the park. The consultant team will attend and discuss options and recommendations.

#### B. Presentation: Town Center on Main Design

Staff from Clark Patterson Lee will attend and update the Council on the status of the park design.

C. Staff Updates - The following items are not planned for discussion at the workshop, unless specifically requested by Council.

### I. 2040 Comprehensive Plan

Staff and the consulting team are preparing the preliminary draft of the 2040 Comprehensive Plan for Council review. The draft plan will be presented at the January 2nd Planning Commission Meeting. A final draft will be submitted to ARC and DCA for review after Council approves this submission, which is anticipated at the January Council meeting. Once ARC and DCA review the plan, Council may officially adopt the plan.

### 2. Apartment Inspections Program

The first apartment inspection has been completed (Landmark at Grand Oasis). Staff plans to proceed with the next two developments (Residences on McGinnis Ferry).

### 3. City Website

Staff has completed the basic look and feel of the new website and is now working on the content portion of the project. The launch date for the new city website is scheduled for February 19, 2018.

#### 4. Election Certification

Council will need to adopt a resolution certifying the results of the November 7<sup>th</sup> municipal election. This will be included on the <u>December 12<sup>th</sup> consent agenda</u>, unless Council prefers otherwise. Results are as follows:

- D. RZ-2017-009 Owner: Karen Williams. Applicant: Jennifer Spencer. The applicant requests a rezoning from R-100 (Residential Single-Family District) to OTCD (Old Town Commercial District) to allow for a reception hall. Site contains approximately 1.5 acres in Land Lot 210 of the 7th District and is located along White Street across from White Street Park.

Due to a recent death, the applicant plans to request postponement to a future date to be determined.

- E. RZ-2017-010 Owner: Jimmy C. Barrett. Applicant: Pollack Shores Real Estate Group. The applicant requests a rezoning from M-I (Light Industry District) to PMUD (Planned Mixed-Use Development) to allow for a mixed-use development including commercial and multifamily uses. Site contains plus or minus 14 acres in Land Lot 236 and 252 of the 7<sup>th</sup> District and is located along Suwanee Dam Road near the northeast corner of Suwanee Dam Road and Peachtree Industrial Boulevard.
- **F. North Gwinnett Arts Association Agreement Renewal and Modification** Staff will present the new NGAA contract proposal. Consideration of this item will be included on the <u>December 12<sup>th</sup> regular agenda</u>.
- G. Harvest Farm Revised Bylaws

The Harvest Farm bylaws contain a sunset provision for this board to terminate on December 31, 2017. Staff recommends deleting this sunset provision. Additionally, staff recommends amending the membership requirements to allow a Board member to either have a plot in the community garden and/or actively volunteer in the orchard by serving on the "Friends of the Orchard" committee, a subcommittee of Harvest Farm that is chaired by Roger Grant. Consideration of this item will be included on the <u>December 12<sup>th</sup> regular agenda</u>.

- H. 2018 LMIG (Local Maintenance & Improvement Grant) Grant Application to the Georgia Department of Transportation and authorize the Mayor to execute Local Government Affidavit and Certification document GaDOT has requested that the city submit its 2018 LMIG street resurfacing improvement program, together with Local Government Affidavit and Certification form. This will be included on the December 12<sup>th</sup> consent agenda, unless Council prefers otherwise.
- I. Intergovernmental Agreement with Gwinnett County to provide for an inmate work crew to perform various duties and authorize the Mayor to execute Agreement

Staff recommends approval of the proposed Intergovernmental Service Agreement with Gwinnett County Department of Corrections for an inmate detail service. This will be included on the December 12<sup>th</sup> consent agenda, unless Council prefers otherwise.
