I. Stormwater Projects

The City has contracted out stormwater projects for Surveyors Point, Rising Fawn Trail, Eryn Circle and Timberlost Trail.

2. Transportation Safety Projects

Staff has identified safety projects on the Martin Farm Road bridge, Brogdon Road, Scales Road, Settles Bridge Road and Eva Kennedy Road. Staff recommends applying for a grant through the 2016 LMIG Off-System Safety Projects which will fund 70% of the project cost with a 30% City match. Approval of the grant application will be included on the <u>April 26 consent agenda</u>, unless Council prefers otherwise.

3. Alcohol Beverage License - Sabores Mexico

Mr. Jose Herrera has applied for an on-premise consumption license for beer, wine, and distilled spirits at Sabores Mexico restaurant, located at 3255 Lawrenceville Suwanee Rd, Ste. T. Staff has reviewed the application and recommends approval. Consideration of this item will be included on the <u>April 26 public hearing and regular agenda</u>.

4. Alcohol Beverage License - PK Tunn

Mr. Ahmed Ashrafi has applied for an on-premise consumption license for beer, wine, and distilled spirits at PK Tunn restaurant, located at 3103 A Lawrenceville Suwanee Road. Staff has reviewed the application and recommends approval. Consideration of this item will be included on the <u>April 26 public hearing and regular agenda</u>.

5. Alcohol Beverage License - Y Restaurant Suwanee

I. Town Center Park West

Per discussion, the City has entered into contract with Clark Patterson Lee with sub consultants JB+A and Lord Aeck Sargent to complete the concept planning for Town Center Park West (Delay property).
