A. Public Arts Commission Update

B. Staff Updates - The following items are not planned for discussion at the workshop, unless specifically requested by Council.

1. Alcohol Beverage License – Vice Bar & Bistro, 45 Satellite Blvd., Suite G

Mr. Cordaveious DeShaun Brown has applied to sell distilled spirits at his restaurant, which already has a license to sell beer a wine. The Business Services department has reviewed the application and recommends approval. This application will be included on the September 22nd public hearing and regular agenda, unless Council prefers otherwise.

2. Alcohol Beverage License – Taco Mac, 3443 Lawrenceville Suwanee Road

The restaurant has applied for a new licensee for their alcohol beverage license. Mrs. Shannayl Deckard is the applicant. The Business Services department has reviewed the application and recommends approval. This application will be included on the

September 22nd public hearing and regular agenda, unless Council prefers otherwise.

3. Town Center LED Retrofit Project

This project is now complete.

4. LMIG Resurfacing Project

Staff is preparing the bid package for the LMIG resurfacing projects. Tentatively, we anticipate releasing the bid in September for Council's consideration to award a contract in October.

5. Municipal Court Bailiffs

As part of the FY 16 budget, staff proposed using a pool of civilian bailiffs for Municipal Court in order to maximize the use of Police resources for Court. Interviews have been completed and staff has selected four bailiffs for this pool. They will be trained in late September and begin working in the court in October.
