I. Probation RFP

The RFP for the City's probation services contract is currently out. Proposals are due on April 30. Staff will update Council as the process proceeds.

2. APA National Conference

This year's annual national conference of the American Planning Association will be held in Atlanta from April 26th to April 30th. The City submitted a proposal and was selected to host a mobile workshop during the conference. Up to 50 city planners from around the world will be visiting Downtown Suwanee on Monday, April 28th from approximately 9:30 AM to noon. Staff will be educating attendees on the development of Suwanee Town Center and other nearby amenities. The official title of the mobile workshop is "Placemaking in Suwanee Town Center."

3. Alcohol Beverage License: Gom Shabu, 3131 Lawrenceville Suwanee Rd, Suite C-I Gom Shabu has applied for a license for the on-premise consumption of beer, wine, and distilled spirits. Mr. Tae Sung Kim is the applicant. The Finance department has reviewed the application and recommends approval. Consideration of this item will be included on the April 22 public hearing and regular agenda, unless Council prefers otherwise.
