The City has received bids to complete the next phase of the parks video surveillance system, to include additional surveillance at George Pierce Park, installation of systems at Town Center Park and Sims Lake Park, and WiFi for Town Center Park and a portion of Sims Lake Park. Staff recommends awarding the contract to the low bidder, C3 Communications, in the amount of \$129,838.50.
