I. Go! Suwanee App



The Go! Suwanee app was officially launched on Suwanee Day and is available in the Apple and Google Play app stores. Citizens may also submit service requests now via the City's website. As of October 1, there have been 626 app downloads.

2. MS4 Permit Renewal

The City's existing MS4 NPDES permit expires on June 11, 2014. Council approval is needed to submit the application. Consideration of the permit renewal will be included on the <u>October 22 consent</u> agenda, unless Council prefers otherwise.

3. Resurfacing Projects

As of October 1st, Allied Paving Contractors, Inc. has completed the milling, patching, and asphalt resurfacing work on the 2013 LMIG Resurfacing Projects. Some pavement markings such as stop bars, shoulder work, and turf establishment remain to be completed.

4. Buford Highway Reconstruction Project

The City has issued an RFQ for Design and Construction Administration Services for the Buford Highway Reconstruction Project. A pre-submittal meeting will be held October 16th and the submittal deadline is November 8th. A selection committee will review the proposals and interview the potential consultants. The selection committee should have a recommendation for Council by the December Council Meeting.

5. Student Youth Leadership Council (SYLC)



Applications for SYLC participants are due October 25 and the selection committee will begin reviewing them the first week of November. The application is available on suwanee.com. The program is being promoted at Peachtree Ridge HS, North Gwinnett HS, and through City avenues (for private and home school students).

E. Residential On-Street Parking

The City periodically receives complaints about vehicles parked on neighborhood streets that block the flow of traffic. Historically, these complaints have been reviewed and resolved by staff on a case by case basis. This presents a challenge for staff because there is no mechanism for uncovering the depth of the problem. As such, staff completed some research and developed recommendations intended to equip the City to address onstreet parking issues.
