10. Consider RZ-2010-001 – Applicant: John Thomas Partners, LLC. Owner: First Covenant Bank. Requests a rezoning from PMUD (Planned Mixed Use District) to PMUD with a change of conditions (to allow for construction of 43 townhomes). The site is located in Land Lot 208 of the 7th District along Park Pass Way and contains approximately 4.49 acres.

11. Consider Adoption of Pawn Shop Ordinance

Staff recommends adopting an ordinance to further regulate pawn shops operating in the City. The City currently has no pawn shops. This ordinance would establish certain operating requirements should one open in the future.

12. Consider Adoption of Precious Metals Dealers Ordinance

In conjunction with the Pawn Shop Ordinance, staff also recommends adopting a Precious Metals Ordinance. Such an ordinance would require businesses that purchase gold and jewelry to photograph and fingerprint patrons in an effort to stop stolen items from being sold in the city. Gwinnett County has recently adopted such an ordinance and staff recommends using theirs as a model.

13. Consider Authorizing the Mayor to Execute an Agreement with Utility Management Services, Inc. for Utility Rate Audit and Rate Adjustment Negotiation Services

Staff is evaluating a program to audit the rates charged to the City for its metered utility accounts. Staff seeks authorization to contract with Utility Management Services, Inc., should

the program be determined suitable. Utility Management Services, Inc. would review each of the City's metered accounts and determine if the correct rate structure is in place. The company would then negotiate with the utility provider accordingly for rate structure revisions and possible refunds.

14. Consider Adjustment to FY 10 Budget for Expenditures Related to the Emergency Stormdrainage Repairs to Settles Point Road

This budget adjustment will transfer \$240,000 from the General Fund (fund balance) to Fund 345 (Storm Drainage) to complete this emergency storm drainage project.

15. Consider Ratification of the Contract with ISC, Inc. for Emergency Stormdrainage Repairs to Settles Point Road

The City Council authorized staff to proceed with this project at the January meeting. The contract for this work was issued to ISC, Inc. This item is the ratification of this contract execution.
