- c) **Adopt Resolution to Amend Existing Outdoor Water Use Ordinance by Adoption of Newly Developed Water Resources Ordinance**
The General Assembly of the State of Georgia has required all cities and counties with water systems in Georgia to adopt an ordinance to be in effect no later than January 1, 2011, to restrict outdoor watering of landscape between the hours of 10:00 a.m. and 4:00 p.m. with certain exceptions.
