

On May 2, 2018, Georgia Governor Nathan Deal signed House Bill 673, or the Hands-Free Georgia Act, which went into effect on July 1.

#### **DRIVERS CANNOT:**

- Hold phones in their hands
- Read or text
- Record or broadcast video while behind the wheel

Basically, the new law means you cannot operate a motor vehicle while operating a cell phone, holding a cell phone with your hand, or supporting a cell phone with another part of your body. As long as drivers do not have a phone in their hand or supported by any part of their body, they can make and receive phone calls through the speakerphone feature, earpiece, and wireless headset or if their phone is connected to an electronic watch or their vehicle's stereo. Drivers can also use GPS and navigational devices via handsfree methods.

In an effort to provide clarification of the new law, we posed a few possible scenarios to Suwanee Police Chief Mike Jones and let him tell us how to proceed under the law.

### I have an older car without Bluetooth technology. If my wife calls while I'm on my way home to ask me to pick-up milk, can I answer it?

The law does allow for a 'single touch,' so if your phone is mounted to your dash, you can answer it on speaker phone and find out if she wants skim or 2%. You could also invest in an earpiece with a microphone, headphone, or smart watch, all of which are legal under the new law. Please note that earpieces/headphones can only be used for communication purposes, not to listen to music or other entertainment.

#### Sometimes when I'm streaming music, a bad song comes on. Like, really bad. "We Built This City" bad. Am I allowed to change it?

The Hands-Free Georgia Act has opened up a Pandora's Box about the use of things such as Pandora. Drivers can listen to music through streaming apps on their phone, but they cannot activate apps or change music through their phone while driving. Music streaming apps programmed and controlled through the vehicle's radio system are allowed. While some might consider Jefferson Starship over the airwaves an emergency, please don't call 911 either.

- > My texting-only Millennial sister sent me a picture of a truly heinous wedding dress via text, along with the message, "I found the one, buying now!"

  It is imperative that I stop her from making this mistake, but I'm sitting in stop-and-go traffic on the interstate. Can I type out a quick reply?

  Drivers cannot at any time use their phones to write, read, and send text messages, emails, update social media, or use the Internet. The use of voice-to-text technology is allowed. Otherwise, your sister is
- If I'm driving down PIB and get a hankering for some waffle fries, can I place my order on the Chick-Fil-A mobile app so I can pick them up in the drivethru?

going to have to live with her own bad judgment.

You can place your order while legally parked, but not while you're cruising down PIB. FYI, "legally parked" does not mean at a stoplight or in gridlocked traffic.

### ) I'm headed to my ALTA tennis match and have no idea where I'm going. Do I need to print MapQuest directions, like in the olden days?

Navigation/GPS may only be accessed by the driver while vehicle is lawfully parked. The screen may be viewed while the vehicle is in motion but may not be held or supported by any part of the driver's body. Basically, plug in your destination before you pull out of the driveway and don't touch it until you arrive.

- > What if I witness an accident and need to call 911? Exceptions to the law include reporting traffic accidents, medical emergencies, fires, crimes, or hazardous road conditions. First responders are also allowed to utilize their phones in the performance of their official duties.
- What if I see an adorable dog hanging his head out the sunroof in front of me with his slobber going everywhere and I want to video it?

The hands-free law prohibits drivers from watching as well as recording videos, though GPS navigational videos and continuously running dash cams are permitted.

The Georgia Governor's Office of Highway Safety stated that nearly all motor vehicle crashes are a result of distracted driving, simply because one of the drivers involved wasn't paying attention to the road. According to the National Highway Traffic Safety Administration, distracted driving caused 391,000 accidents with injuries in 2015 and 3,450 accidents with fatalities in 2016. Thirteen of the 15 states that already have similar laws have seen at least a 16 percent decrease in traffic deaths.

SUWANEE BEGINS NEW FISCAL YEAR WITH \$13.4 MILLION BUDGET

The City of Suwanee began the new fiscal year July 1 with a \$13.4 million balanced operating budget. This year's budget represents a 3.4 percent increase over the \$12.9 million adopted budget for the recently ended 2018 fiscal year.

## Suwanee's \$13,366,910 FY2019 budget includes:

full time and 17 part-time positions, including five new positions and two position upgrades

The FY2019 budget is based upon the assumed millage rate of 4.93 mills, which is the same rate used by the city over the past five years. The actual millage rate will be set at the August 28 City Council meeting after public hearings at City Hall on August 16 at 5:30 pm and August 28 at 12:00 pm and 6:30 pm.

# CITY OF SUWANEE OPEN BUDGET

In an effort to provide complete and clear financial information, the City of Suwanee launched an open budget website in October 2017, ensuring that city financial data is easily accessible and understandable for citizens.

This program brings life to the city's static citizen operating budget: it makes the numbers interactive and shows the annual progress of collections and expenditures. This system provides transparency of how the budget is performing on an ongoing basis, rather than a snapshot of a moment in time.

"We're big believers in authenticity and transparency in government. Our citizens should be able to easily access and understand our spending. At its most simplified, this is the taxpayers' money, and it's their right to know that we are being fiscally responsible with their dollars," said Amie Sakmar, Suwanee's Director of Finance. "The open data website is incredibly intuitive and allows citizens to dig as far as their interests take them."

Rather than wading through hundreds of pages of scanned legal and financial documents, citizens and staff see financial data contextualized in charts, graphs, and images that are attractive, navigable, and easy to understand.

"The ability to obtain current information in different formats helps decision makers be successful in monitoring financial data, understanding trends, and identify budgetary problems before they occur," said Sakmar. "If our mayor likes looking at information as a bar graph, he can do it. The city clerk prefers a pie chart? She can do it. Planning director wants to know what has happened over the past five years? It can easily be done."

"In the end, everything rolls or passes through finance. Suwanee has a great story to tell, and the finance department is in a unique position to tell this story," said Sakmar. "I try to capture Suwanee's vibe by making the documents fun, interesting, and factual, engaging the reader to follow along and share Suwanee's story. At the heart of it, I am a geeky number person who loves financial reporting (and Suwanee), and wants to share this enthusiasm with the reader."

Aside from having fun with the presentations of her work, the actual numbers and financial plan are also valued for the efforts put into them. The Governments Finance Officers Association (GFOA) claimed the 2017 Fiscal Year budget as an 'Exemplary Policy Plan,' stating, "Overall this budget presentation includes a strategic plan that will lead the city into the future with confidence

and sound financial and operational planning." The strength of the City of Suwanee's financial documents allows for participation in all three GFOA award programs, which isn't common. Recognition from GFOA includes:

- Certificate of Achievement for Excellence in Financial Reporting - 2003-present
- Distinguished Budget Presentation Award 2006-present
- Outstanding Achievement in Popular Annual Finance Reporting - 2010-present

The city has also received special performance measurement recognition three times for budget documents, as well as the Certificate of Distinction in Performance Management from International City/County Management Association – 2011-present.


