#### A. Call to Order

Mayor Burnette called the meeting to order at 6:34 PM.

#### B. Organizational Matters for 2019

#### 1. Oath of Office

The oath of office was administered for 2019 Election Superintendent, Elvira Rogers, by Gregory Jay, City Attorney.

# 2. Selection of Mayor Pro Tempore

In accordance with Section 2.27 of the City Charter, by a majority of vote, the City Council shall elect a Councilmember to serve as Mayor Pro Tempore for that ensuing year. The Mayor Pro Tempore shall assume duties and powers of the Mayor during the Mayor's disability or absence.

Motion by Councilmember Miller to select Dick Goodman as Mayor Pro Tempore, second by Councilmember Ireland and so carried 6-0.

#### 3. Adoption of Rules and Procedures

In accordance with Section 2.19 of the City Charter, the City Council shall each year adopt its rules of procedure and order of business. Staff recommends adopting the current edition of Robert's Rules of Order.

Motion to approve by Councilmember Ireland, second by Mayor Pro Tempore Goodman and so carried 6-0.

#### C. Public Hearing

Mayor Burnette read the procedures for Public Hearings for the record.

#### 1. Twisted Taco Alcohol Beverage License

Twisted Taco, located at 3433 Lawrenceville Suwanee Road, has applied for a new licensee for their alcohol beverage license. Ms. Mikyung Kim has applied as the licensee and the Business Services department recommends approval of the license. The applicant was present. There was no audience comment.

2. RZ-2019-001 - Owners: FGM Organizations Inc. and Vanessa B. Johnson. Applicant: O'Dwyer Properties. The applicant requests a rezoning from GC-A (Gwinnett County Annexed) to R-75 (Single Family Residence District) to allow for detached single-family homes. The site is located on 90 Morning Glen Drive

Josh Campbell, Planning Director presented the staff analysis. The Planning Commission voted 3-0 for approval with conditions. The Planning Department recommends approval with conditions of the request. The surrounding area is characterized as single family residential. The Future Land Use Plan recommends single family detached. There was one concern in the Planning Commission meeting regarding construction traffic impact on the neighborhood. Staff has addressed these concern and added a condition included in the conditions dated January 22, 2019.

Support – Shane Lannon, 1550 North Brown Road. Jordan Tench, 1430 Crabapple Road, Roswell. Approximately 25 residential home. Price point starting in the \$400's with 2000-4000 sq. ft. The applicant is in agreement with the conditions addressing construction traffic.

Opposition – Jim Singleton, 3223 Maple Terrace Drive, 24 year resident of Avonlea Crossing. Mr. Singleton expressed concern for water runoff, buffers between properties, construction time and construction noise.

Applicant rebuttal – A rear building set back is shown as 30 feet. The intent of the developer is to leave the vegetation undisturbed as much as possible. The proposed home will be approximately 50 feet from the rear property line. Weather depending, the timeline is a 2 year process.

Josh Campbell stated there are stormwater plans and engineering plans that will need to be reviewed, approved and monitored by the City.

# M. Consider Award of Contract to IPR Southeast, LLC for Stormwater Project on Grand Vista Approach and Chattahoochee Run Drive

Staff recommends awarding a contract to IPR Southeast, LLC, in the amount of approximately \$115,693.60. The project scope includes 891 linear feet of corrugated metal pipe cleaning, camera work, repair and concrete relining work on Grand Vista Approach and Chattahoochee Run Drive. Staff recommends piggybacking on the existing City of Dunwoody Contract for this vendor.
