A. Call to Order

Mayor Burnette called the meeting to order at 6:35 p.m., and read the procuedures for Public Meetings for the record.

B. Public Hearing

1. RZ-2015-005 – REZONING OF 32.2 ACRES FROM R-100 & C-2 TO PMUD. APPLICANT: VANQUISH PROPERTY PARTNERS, LLC. LOCATION: WHITE STREET AND WHITE LANE/BUFORD HIGHWAY

Josh Campbell, Planning Director, presented the staff analysis. This rezoning is for a new development near White Street Park and includes a mixture of cottages, single family detached, townhomes and a few stacked flats. Staff has met with the applicant to come to a concensus on the site plan and architecture. Staff and the Planning Commission recommends approval with conditions. If Council desires to approve this rezoning, staff recommends approval with conditions dated April 25, 2016. In the future, this project will require abandonment of the road right-of-way, prescriptive easements and easements through the White Street Park property for sewer. If approved with the conditions before Council tonight, the project will be heard again by Council prior to receiving a development permit to approve the Plan Book.

2. RZ-2016-001 – REZONING OF 26.2 ACRES FROM R-100 & C-2 TO PMUD. APPLICANT: VANQUISH PROPERTY PARTNERS, LLC. LOCATION: LAND LOT 210 OF THE 7TH DISTRICT, 706 & 740 BUFORD HIGHWAY

Josh Campbell, Planning Director, presented the staff analysis. This is a 26 acre site, about half of the site is in flood plain. The community will have private streets maintained by the neighborhood. 29 units are townhomes and the remainder are units made to look like townhomes. Staff and Planning Commission recommended approval with conditions. Condition #11 deals with sidewalks including a 10 foot multi-path along Buford Highway. If Council desires to approve this rezoning, staff recommends approval with conditions dated April 25, 2016

Staff recommends applying for a grant through the 2016 LMIG Off-System Safety Projects which will fund 70% of the project cost with a 30% City match.
