Consideration of this license will be included on the February 25<sup>th</sup> public hearing and regular agenda.*

**2. Art for All Grant Opportunities**

*Staff is planning to apply for three grants to benefit the Art for All Capital Campaign. Grant opportunities include the Tull Foundation (requesting \$75K arts and culture grant; application due 4/1/20), the Scott Hudgens Family Foundation (requesting \$50K; application due 2/17/20), and the Community Foundation for NE Georgia (requesting \$50K-100K; request letter to be completed 2/2020). None of these require specific matching funds.*

**3. GMA/GMEBS Retirement Amendment**

*Staff received documents from GMA outlining consolidated changes to the Master Document for the Defined Benefit Plan managed GMA/GMEBS. GMEBS has recently received a favorable determination letter from the IRS. Each employer using the GMEBS Plan is required to adopt the restated Adoption Agreement as part of the restatement process. Consideration of this amendment will be included on the February 25<sup>th</sup> regular agenda.*
