A. Call to Order

Mayor Burnette called the meeting to order at 6:33 P.M., and read the procedures for Public Hearings for the record

B. Public Hearing

1. 2016 Millage Rate

Marty Allen stated we have received our 2016 tax consolidation information from Gwinnett County. After analyzing the data provided from Gwinnett County, staff recommends a proposed millage rate of 4.93 mills, the same proposed millage rate used in the adopted FY 2017 budget and the same millage rate as the past four years. In accordance with state law, three public hearings were scheduled on the proposed millage rate; this is the final of the three hearings.

2. RZ 2016-004 – Owner: Donald Johnsa. Applicant: Lynwood Development. The applicant requests a rezoning from M-1 (Light Industry District) and R-140 (Residential Single Family District) to PMUD (Planned Mixed-Use Development) to allow for a mixed-use development. The site is located in Land Lot 236 of the 7th District at 450 Buford Highway and contains approximately 18.0 acres

Josh Campbell, Planning Director, stated this rezoning case was postponed at the P&Z Meeting at the request of the applicant. There was no audience comment.

K. Consider GaDOT Memorandum of Understanding Regarding Buford Highway Water Line Relocation

Staff recommends executing a Memorandum of Understanding with GaDOT to bid relocation of City water lines with the overall project.

Motion by Mayor Pro Tempore Miller to authorize the Mayor to execute the GADOT Memorandum of Understanding Regarding Buford Highway Water Line Relocation, second by Councilmember Goodman and so carried 6-0.

L. Consider Change Order to Brushy Creek Greenway Project

This project has been finalized and came in approximately \$35,000 under budget. Staff recommends adopting a change order to reflect the final project amount of \$559,828 (originally adopted at \$595,222) in order to officially close the project out.

Motion by Councilmember Ireland to approve the Change Order to Brushy Creek Greenway Project, second by Councilmember Hilscher and so carried 6-0.

M. Consider Alcohol Ordinance Amendment

Staff recommends an amendment to the alcohol ordinance for consistency with state law regarding the sale of alcohol for consumption on the premises and the sale of alcohol in grocery stores.
