A. Call to Order

Mayor Burnette called the meeting to order at 6:39 P.M., and read the procedures for Public Hearings for the record.

B. Public Hearing

1. RZ 2016-004 – Owner: Donald Johnsa. Applicant: Lynwood Development. The applicant requests a rezoning from M-1 (Light Industry District) and R-140 (Residential Single Family District) to PMUD (Planned Mixed-Use Development) to allow for a mixed-use development. The site is located in Land Lot 236 of the 7th District at 450 Buford Highway and contains approximately 18.0 acres

Josh Campbell, Planning Director, presented the staff analysis. The project is approximately 240 multi-family units, up to 30,000 sq. ft. commercial, and 71 townhomes. This property is an expansion of a previous rezoning. Staff and the Planning Commission recommended approval of the request with conditions. The development would have the look and style and mixed use environment as Town Center. Should Council desire to approve the request, staff recommends approval with conditions dated 11/14/2016.

Support:

- Marian Adeimy, Esq., Andersen, Tate & Carr, PC, One Sugarloaf Centre, Suite 4000, 1960 Satellite Boulevard, Duluth, GA 30097, represented the applicant. Lynwood Development has been successful to work with Terwilliger Pappas and the lumber yard to assist the City is fulfilling a Master Plan initiative. This project introduces a high end product to Suwanee Town Center. Townhomes will be a mixture of rear and front entry, pocket parks, pedestrian travel ease, and an opportunity for future development along Buford Highway with a mixture of retail uses. The applicant is in agreement with staff recommended conditions. Completion of the development will include approximately 4.5 acres of greenspace, pedestrian connectivity and add 150 parking spaces in the deck near the front retail portion of the property.
- Greg Power, Terwilliger Pappas, 2472 Fernleaf Court, Atlanta, GA 30318. Project originally zoned on 3 acres in September 2015. They have acquired the additional 15 acres to provide the project presented today.

2. RZ 2016-005 – Owner: Mun Sun Hui. Applicant: Caddis Acquisition Partners. The applicant requests a rezoning from M-1 and C-1 to PMUD to allow for a senior living facility. The site is located in Land Lot 236 of the 7th District at the intersection of Suwanee Dam Road and Brogdon Road and contains approximately 10 acres

Josh Campbell, Planning Director presented the staff analysis. The proposed project is 171 units with a mixture of independent living units, assisted living units and memory care. It is proposed to be 73,000 sq. ft. of living space to include 59 assisted living units, 32 memory care beds and 83 living units. The proposal is in accordance with the Future Land Use Plan. Staff & Planning Commission recommends approval. Should Council desire to approve the rezoning, staff recommends approval with 11/3/2016 conditions.

Support:

• Judd Jacobs, Caddas, 5910 North Central Express Way, Dallas, TX 75206. This is a senior living community. The applicant adhere to recommendations and build up to the street giving the same look as Town Center. Just recently broke ground in Fayetteville on a similar facility. This will not be skilled nursing or a nursing home.
