## 2. Announcements

- **a.** The 2015-2017 <u>SculpTour</u> is officially open. Suwanee's fourth SculplTour exhibit features <u>17 sculptures</u>, more than ever before. A total of 15 artists represented, with six from Georgia and other artists from Tennessee, North Carolina, South Carolina, and New York City. To take a <u>self-guided tour</u> of the exhibit, pick up a printed guide from City Hall or download one at suwanee.com. Be sure to vote via the Community/SculpTour page at suwanee.com for your favorite piece and increase its chances of being the one that the City purchases to add to its permanent art collection at the end of the exhibit.
- b. The City of Suwanee will host two events the first weekend of June: <u>Food Truck</u>
  <u>Friday on June 5 and a double-feature Movies Under the Stars on Saturday, June</u>
  <u>6</u>.

The tentative food truck line-up includes Atlanta Burger Truck, Bollywood Zing, Five Finger Philly, Pressed for Time, Freckled and Blue, Happy Belly, Linkz Express, On Tapa the World, Rey's Cuban Café, Wow!, and Yoli's Street Food. The <u>musical line-up</u>, <u>presented by Town Center Music</u>, features Jon Cole and Liz Brasher & Her Band. Food will be served from 5:30-9:30 p.m. with music starting about 7.

Two movies will be shown during the June 6 Movies Under the Stars event. The 7 p.m. movie is Alexander and the Terrible, Horrible, No Good, Very Bad Day. The third installment of the Hunger Games series, Mockingjay – Part 1, will be the second feature, starting around 8:45 p.m.

- c. These are the final few days to find a piece from the annual Art on a Limb program. Two pieces of original artwork have been hidden along the Suwanee Creek Greenway, at White Street Park or at Sims Lake Park daily throughout the month of May. The final pieces will be hidden each day this week, through Sunday. Suwanee's Art on a Limb program is an annual celebration of art and nature that allows those who find the trail treasures to keep them. This year's pieces are red clay hearts with warm, fuzzy Suwanee statements on them that were created by Suwanee area resident Tina Waltke.
