A. Call to Order

Mayor Burnette called the meeting to order at 6:36 PM.

B. Public Hearing

1. Alcohol Beverage License – Vice Bar & Bistro, 45 Satellite Blvd., Suite G Mr. Cordaveious DeShaun Brown has applied to sell distilled spirits at his restaurant, which already has a license to sell beer and wine. This application was postponed last month. Mr. Allen stated there are still issues being worked

through regarding this license request. Staff recommends postponing the request another month (November 17, 2015).

2. Alcohol Beverage License – Los Barsas Mexican Grill, 360 Peachtree Industrial Blvd., Suite 101B

Mr. Jesus Mata has applied for a license to sell beer, wine, and distilled spirits. The Business Services department has reviewed the application and recommends approval.

Mayor Burnette read the procedures for Public Hearings for the record.

3. SUP 2015-005 – Owner: Errol Kantor. Applicant: Nick Ali. The applicant requests a special use permit to allow for the expansion of a gas station/automotive service and repair facility. The site is located at 3034 Lawrenceville Suwanee Road and contains approximately 0.66 acres.

Josh Campbell, Planning Director, presented the staff analysis as follows: The request is to expand an existing gas station/automotive service and repair facility. The current facility is a 2100 sq. ft. 2 garage bay service station with 4 gas pumps. The proposed expansion will be 3600 sq. ft. with 8 bays, keeping the current gas pumps. Architectural enhancements will be made to the building with bricked gas pumps. This is a highly commercialized area with similar uses in the area. The Future Land Use Plan shows high density office, but also speaks to a positive first image. If the project is approved conditions are necessary to address storage of tires on the site, architecture of the building and landscaping. The Planning Commission recommended approval with an added condition to address storage on site. If Council desires to approve the request, staff recommends approval with Planning Commission conditions.

Nick Ali, 3974 Beddington Lane, Duluth, GA 30097. Mr Ali, stated he is
the new owner trying to get the Shell station to look like a more advanced
nice looking building. He was involved in the Chevron/Dunkin Donut
project.

Councilmember Ireland asked about parking needs and staff members. Mr. Ali, stated the staff will be he and his wife. Councilmember Ireland asked about additional workers who will handle customer services in the bays. Mr. Ali, stated there will be approximately 5 employees including himself. Councilmember Ireland expressed concern there would not be enough parking for vehicles waiting for repair, future clients and staff with the 30 spaces projected for the site. Mr. Ali stated he has been in conversation with the County and the State for use of Burnette Road for increased parking.

Staff has reviewed the bids and recommends awarding to Peach State Construction Company in an amount not to exceed \$595,222.

Award Contract to Allied Paving Contractors, Inc. in the Amount of \$828,208.35 The City has released bid packages for the LMIG resurfacing project, to include resurfacing of approximately 3.4 miles of City streets, as well as additional parking at Sims Lake Park. The City received three bids on this project and Allied Paving Contractors, Inc., of Pendergrass, GA, was the low bidder.
