• We're proud to announce that the City of Suwanee <u>Police Department</u> has once again received <u>statewide certification</u> from the Georgia Association of Chiefs of Police. State certification, which the Suwanee law enforcement agency <u>first earned in 2000</u>, confirms that <u>agency practices</u> are consistent with progressive professional standards. State certification is valid for three years. In 2010, the Suwanee Police Department was nationally accredited for the first time by the Commission on Accreditation for Law Enforcement Agencies (CALEA). Suwanee is scheduled to be <u>reviewed by CALEA for re-accreditation</u> later this year.

- The City's <u>budget document</u> is another <u>repeat award winner</u>. The Government Finance Officers Association awarded the <u>Distinguished</u> <u>Budget Presentation Award</u> to the City's FY 13 budget. 1. Authorize Mayor to Enter into an Agreement with Gwinnett County for McGinnis Ferry Rd. and PIB Intersection Improvements

The City and County have negotiated an agreement for the County to upgrade the pedestrian access facilities at the intersection of McGinnis Ferry Road and Peachtree Industrial Blvd. The City must commit funding for 50% of the design and construction costs, not to exceed \$75,000. As this project was not planned in the CIP, no dedicated funding is currently identified. Staff recommends using the Facilities Enhancement Fund for this expenditure.

2. Accept Irrigation Water Line Easement from Precision Design & Development Company, Inc.

In order to construct the Town Center Park irrigation well, a water line easement is needed along portions of the alley behind the residences on Portland Trail Drive and Suwanee Avenue. The easement is six feet in width with a 10-foot temporary construction easement.
