C. Public Hearing

Mayor Burnette read the Public Hearing rules and procedures for the record.

1. SUP-2013-001 – Applicant: Kyle Manard, LLC. Owner: SNBC, LLC. Requests a special use permit to allow for a health club in the M-1 (Light Industry District) Zoning District. The site is located at 305 Shawnee North Drive and contains approximately 7.80 acres.

Josh Campbell, Planning Director, presented the staff analysis. This is a request for a fitness club to go into a M-1 location. They classes up to 15 people with the larger classes in the evening. Surround areas are M-1 and C-2 uses. SUP required due to M-1 buildings being constructed for storage of items. The SUP would require the applicant to obtain a Certificate of Occupancy for the Fire Marshal and Suwanee's inspection office to confirm occupancy standards are met. Staff recommended approval with conditions. P&Z recommended approval with conditions.
