2. Alcohol License Amendment for Bara 3 LLC, dba Gopchang Salon, 2850 Lawrenceville-Suwanee Road, Suite 10-12

Ms. Dang Hwoi Kim, owner and licensee, has applied to amend the existing alcohol license to include on-premise consumption of distilled spirits for this restaurant located at 2850 Lawrenceville Suwanee Road, Suite 10-12. The Business Services department recommends approval. Consideration of this license amendment will be included on the <u>April 27th public hearing and regular agenda</u>.

3. Big Splash Fountain Opening

The fountain is tentatively scheduled to re-open early July. This will be dependent on required maintenance and will be determined when access is available once the tents are removed. Removal of the tents is tentatively scheduled for late April or early May.

4. Surplus Sale

The city will surplus four police vehicles in the annual surplus sale to be held in early May. Approval of these items will be included on the <u>April 27th consent agenda</u>, unless Council prefers otherwise.

5. Yield Sign at King Street and Martin Farm Road

Due to an absence of traffic control, staff is requesting approval to erect a yield sign at the northwest bound Martin Farm Road at the intersection with King Street. This will be on the April 27th Council Consent Agenda, unless Council prefers otherwise.

E. Elevated Water Tank Painting

The interior coating and exterior finish need to be repainted on the elevated water tank. The estimated cost is \$181,500. Bid opening is scheduled for April 29^{th} .

G. RZ-2021-004 - Owner: Keith and Barbara Maddox. Applicant: Edward Townsend

The applicant requests a rezoning from R-100 (Residential Single Family District) to IRD (Infill Residential District) to allow for detached single family homes. The site is located at 481 Main Street and contains approximately 1.38 acres. The Planning Department recommends approval with conditions. This item will be on the <u>April 27th Council Public Hearing and Regular Agenda</u>, unless Council prefers otherwise.

H. Suwanee Pedestrian and Bicycle Loop Study

J. MRPA Certificate

There is a development under review for a land disturbance permit that is within the Chattahoochee River Corridor. State regulations require that the developer go through a review to certify that the development is in compliance with the Metropolitan River Protection Act. The Atlanta Regional Commission has determined that the development plans are consistent with the requirements of the MRPA. City Council approval is needed for the MRPA certification before a Development Permit can be issued. The MRPA also requires the city as the local jurisdiction to hold a Public Hearing prior to voting on issuance of an MRPA Certificate. This item will be on the <u>April 27th Council Public Hearing and Regular Agenda</u>, unless Council prefers otherwise.

K. 3rd Quarter Financial Review and Budget Adjustments

Staff will review FY 2021 general fund performance, 3rd quarter proposed budget adjustments, and proposed capital improvement pre-funding for FY 2022. 3rd quarter budget adjustments will be on the <u>April 27th Council Consent Agenda</u>, unless Council prefers otherwise.

L. New Police Department CAD/RMS Software

The Police Department is seeking to replace their existing Computer-Aided Dispatch and Record Management System software with a software package offered by Central Square. Gwinnett County Police, Communications, and Sheriff use this platform and it would allow sharing of data between agencies. Approval of this item will be on the <u>April 27th Council Regular Agenda</u>, unless Council prefers otherwise.
