C. Staff Updates

I. Town Center Fountain

The Public Works department has started the process of cleaning and powering up equipment, including water pumps. As of May 5th the water pumps are functioning well. The fountain is on schedule to be reopened in early July.

2. Police Training Center Retaining Wall

A wooden retaining wall at the Police Training Center was in need of replacement due to rot. The retaining wall was replaced with a concrete block wall and was completed in April.

3. Main Street Landscaping

Landscaping improvements have been underway on Main Street. Tree's, plants and pine straw have been planted in April. Also incorporated to improve drainage, was using cobblestone to create a flume to storm water inlet.

D. RZ-2021-004 - Owner: Keith and Barbara Maddox. Applicant: Edward Townsend

The applicant requests a rezoning from R-100 (Residential Single Family District) to IRD (Infill Residential District) to allow for detached single family homes. The site is located at 481 Main Street and contains approximately 1.38 acres. The Planning Department recommends approval

with conditions. This item will be on the <u>May 25th Council Public Hearing and Regular Agenda</u>, unless Council prefers otherwise.

E. RZ-2021-005 - Owner: J&J Commercial Ventures, LLC. Applicant: Jeff Jones

The applicant requests a rezoning from O-I (Office-Institutional District) to O-I (change of conditions) to allow for the use of existing parking for clients as well as employees. The site is located at 897 Eva Kennedy Road and contains approximately 0.39 acre. The Planning Department recommends approval with conditions. This item will be on the May 25th Council Public Hearing and Regular Agenda, unless Council prefers otherwise.
