# 1. SUP-2021-001 - Owner: Celebration Hospitality, LLC. Applicant: Erica Kennedy

The applicant requests a Special Use Permit to allow for a building height increase for a hotel in the C-2A (Special Commercial District) zoning district. The site is located at 140 Celebration Drive and contains approximately 1.99 acres.

Mr. Josh Campbell described the request, adding that the request is consistent with the surrounding area and the expectations of the comprehensive plan. Mr. Campbell noted that the Planning Department recommends approval with conditions and the Planning Commission recommended approval with staff conditions.

The applicant, Mr. Stephen Overcash, ODA Architecture, 2010 South Triumph Street, Charlotte, NC, addressed Council and noted that the project is in keeping with the area and the comprehensive plan.

# 2. RZ – 2021 – 006 – Owner: Bill Stark Properties, LLC. Applicant: Tonya Woods (postponed by Planning Commission)

The applicant requests a rezoning from R-100 (Residential Single Family District) to IRD (Infill Residential District) to allow for single family detached homes. The site is located at 653 White Street and contains approximately 0.85 acre. The Planning Department recommends approval with conditions.
