COUNCIL WORKSHOP

A. Staff Updates

1. New Solid Waste Service for City Building and Facilities

Effective October 1st, solid waste and recycling services for all city of Suwanee facilities is being provided by Republic Services. This move was due in part by the previous company being bought out, and with Republic already providing roll off container service for Public Works, added improved single stream recycling for all city facilities. Clean paper, carboard, plastic and aluminum cans will be accepted.

2. 2021 Local Maintenance and Improvement Grant Award Bid

On October 22nd a bid opening will take place for the 2021 LMIG road resurfacing project, encompassing 2.54 miles. Staff anticipates that Council's approval of the awarded bid will be requested on the October 28, 2021 Council Regular Agenda.

3. Park Path Improvements

Staff is undertaking two substantial projects to upgrade existing paths in Sims Lake Park and White Park. Both parks have existing asphalt trails that need rehabilitation. In White Street the asphalt path will be converted to concrete. In Sims Lake Park, large sections will be replaced to eliminate hazards. Work should occur within the next 30 days. The parks will require temporary closures at certain times.

4. Permanent Sewer and Temporary Construction Easement for 481 Main Street

The property owner at 481 Main Street is seeking to attached to sewer. They are in the development review process right now for the sewer connection. In order to connect to the sewer line which is located on City property (containing the Brushy Creek Greenway) the property owner will need easements from the City. One 40-foot wide temporary easement would be required for the construction of the sewer line. One 20-foot permanent sewer easement will be needed for the sanitary sewer connection. This item will be on the October 28th Council Regular Agenda, unless Council prefers otherwise.

Staff from Clark Patterson Lee will provide the latest information on the Town Center on Main park project.
