H. Consider Atlanta Gas Light Easement Purchase

To install a new gas pipeline located in the road right of way adjacent to the city's property, Parcel R7250-001, Atlanta Gas Light has submitted an offer to purchase 0.234 acres for a temporary construction easement and .082 acres for a permanent easement.

Councilmember Pettiford motioned to approve authorizing the Mayor to accept the total settlement offer of \$109,300 from Atlanta Gas Light in consideration of the permanent and temporary easements and other considerations on parcel R7250-001, second by Councilmember Charpentier and so carried 6-0.

I. Consider Easements for 481 Main Street

A permanent sewer easement and temporary construction easement is being requested for sewer line construction to serve 481 Main Street.

Councilmember Hilscher motioned to approve sewer easements for 481 Main Street, second by Councilmember Hall and so carried 6-0.

J. Consider Award of Contract for 2021 Local Maintenance and Improvement Project
On October 22nd a bid opening took place for the 2021 Local Maintenance Improvement Grant
(LMIG) road resurfacing project, encompassing 2.54 miles. Staff anticipates presenting
Council with a recommendation when the bids have been reviewed.

Motion to approve the 2021 LMIG project contract with Garrett Paving Company, Inc. by Mayor Pro Tem Miller second by Councilmember Charpentier and so carried 6-0.
