James Burnette was elected Mayor, Doug Ireland was elected to Post 1, Dick Goodman was re-elected to Post 2, and the Alcohol Referendum passed. Council must certify the results from the election.

C. Consider Ordinance to Amend City Code of Ordinances to Provide for and Regulate Sunday Retail Package Sales of Alcoholic Beverages

Pursuant to the outcome of the November 8, 2011 referendum in which City electors approved Sunday retail alcohol sales by a vote of 1,023 to 341, Gregory Jay has prepared an amendment to the Code of Ordinances to allow for this. Adoption of this ordinance would allow for sales beginning Sunday, November 20th.

Motion to approve the Ordinance by Councilmember Foster, second by Mayor-Elect Burnette and so carried 6-0.
