The Atlanta Regional Commission has issued a call for applications for Livable

Centers Initiative (LCI) study grants. Based on the Comprehensive Plan and the current strategic planning initiative, the Suwanee Gateway area around the I-85 interchange is an area that has been identified for redevelopment. This LCI grant would help develop a study of this area to encourage redevelopment. A 20% local match to the grant is required.
