#### A. Call to Order

#### **B.** Public Hearing

#### 1. FY2023 Budget and 2023-2027 Capital Improvement Program

This is the second public hearing for the FY 2023 and 2023-2027 CIP. The first public hearing was held at a Called Meeting on June 16<sup>th</sup>. Assistant City Manager Denise Brinson presented the proposed budget.

## 2. Alcohol Beverage License for HEG, LLC dba Courtyard Marriot, 310 Celebration Drive

HEG, LLC dba Courtyard Marriott, located at 310 Celebration Drive, has applied for an alcohol license for on-premise consumption of beer, wine, and distilled spirits under new ownership. Syed Ali has applied to be the licensee and the Business Services Department recommends approval. No one spoke in support or opposition.

3. **RZ-2022-003** – **Owner/Applicants: Tanya Sola Christiano and Jennifer Spencer** The applicant requests a rezoning from R-100 (Residential Single-Family District) to IRD (Infill Residential District) to allow for single family homes. The site is located at 781 White Street and contains approximately 0.42 acre. The Planning Department recommends approval with conditions. The Planning Commission recommends approval with modifications to staff's conditions, which is to have a 30-foot setback. The applicant, Ms. Tanya Christiano, 781 White Street, appeared before Council in support of the application. No one spoke in opposition.

4. **SUP-2022-002 – Owner: Renato Rodriguez. Applicant: Rivan Peachtree LLC**The applicant requests a Special Use Permit to allow for an automotive use in the C-2 (General Commercial District) zoning district. The site is located at 50 Old Peachtree Road and contains approximately 3.5 acres. The Planning Department and the Planning Commission recommend approval. No one spoke in support or opposition.

## 5. SUP-2022-003 – Owner: The Honeybaked Ham Company, LLC. Applicant: H&G Properties Management, LLC

The applicant requests a Special Use Permit to allow for outdoor storage in the C-2A (Special Commercial District) zoning district. The site is located at 3370 Lawrenceville-Suwanee Road and contains approximately 2.09 acres. The Planning Department recommends approval with conditions. The Planning Commission recommends approval with staff conditions. Mr. Chris Cummings of The Honeybaked Ham Company, LLC, 175 Brittain Way, Newnan, Georgia, appeared before Council in support of the application. No one spoke in opposition.

#### Q. Consent Agenda

#### 1. Approve 4th Quarter Budget Adjustments for Special Revenue

As a part of the fourth quarter special revenue funds budget adjustments, staff is recommending increasing the Suwanee Fest fund budget by \$26,300 and the Hotel/Motel Tax fund budget by \$209,000.

#### 2. Approve 4th Quarter Budget Adjustments for Equipment

As part of the fourth quarter operating budget adjustments, staff is recommending transferring \$144,000 from the general fund to the facilities enhancement fund. These transfers are funding one police vehicle (currently on back order), police equipment, and public works equipment. These adjustments do not increase the total general fund budget.

#### 3. Approve Gwinnett County Easement Request

Gwinnett County is requesting a 5,134 square foot easement for a relocated water line along Buford Highway in front of Suwanee Creek Park.
