#### 3. Call to Order

Mayor Williams called the meeting to order at 7:02 p.m.

#### 4. Announcements

- The City received a CREATE Community Award from the Atlanta Regional Commission last week for our social media initiatives. Presented annually, the CREATE Community awards recognize local government innovations in five categories. Suwanee was the winner in the Application and Innovation in Technology category for our commitment to utilizing social media as a tool to engage citizens and for development of a progressive Social Media Policy. A special thank you to our 2,823 Facebook fans and 377 Twitter followers for helping make the first year of our social media campaign a success.
- Suwanee was recently recognized by the National Arbor Day Foundation for our 20<sup>th</sup> year of being a Tree City USA. The Tree City program provides national recognition for urban and community forestry programs throughout the country. Suwanee joins a group of only 33 cities statewide to earn this designation for 20 years or more.
- Registration is now open for the Police Department's PRIDE teen driving class. The class will be offered, in cooperation with the Georgia Traffic Injury Prevention Institute, from 6:30-8:30 p.m. on Thursday, March 11. This free course assists <u>parents</u> in helping their teens to become safe drivers and offers strategies for required supervised practice driving time. - The City will host a community meeting at 6:30 p.m. on Thursday, February 25, to share plan alternatives being developed as part of the Buford Highway Transportation Study. The meeting will be at the Crossroads Center. The Buford Highway transportation study, covering the area from McGinnis Ferry Road to the entrance of George Pierce Park, has been undertaken to determine what changes are needed to accommodate future development and multiple modes of transportation. Additionally, on Thursday, March 18, the City will host an open house to share a final draft of the plan and receive additional community comments before the plan is considered by City Council. That meeting will be at 6:30 p.m. at City Hall.
- Mayor Williams mentioned that as of Monday, 3/1/2010, the City would lose its qualified local government status. This is due to failure to reach an agreement with Gwinnett County for services. We will not be eligible for some grants and

permits due to losing this status. Court costs are estimated around \$350,000. A court date for March is anticipated.
