### CITY COUNCIL MEETING TUESDAY, AUGUST 23, 2022

#### A. Call to Order

Mayor Burnette called the meeting to order at 6:31 p.m.

### **B.** Public Hearing

#### 1. 2022 Millage Rate

We have received our 2022 tax consolidation information from Gwinnett County. During the FY 2023 budget process, we assumed a millage rate of 4.93, the same millage rate as the past ten years. Marty Allen reviewed the proposed millage rate calculations and property tax allocations.

## 2. Alcohol Beverage License Application for Bionew Kitchen Masters, LLC, 3131 Lawrenceville-Suwanee Road, Suite 5

Bionew Kitchen Masters, LLC, dba Wabi Sabi, located at 3131 Lawrenceville Suwanee Rd Ste 5, has applied for an alcohol beverage license for on-premise consumption of beer, wine, and distilled spirits. Hung Peng has applied to be the licensee and the Business Services Department recommends approval.

# 3. RZ-2022-004 – Owners: 3805 317 LLC and Franklin Property Group LLC. Applicant: Walker Anderson Homes

The applicant requests a rezoning from R-100 (Residential Single-Family District) to RM-8 (Residential Multi-Family Duplex District) to allow for townhomes. The site is located at the southeast corner of Lawrenceville-Suwanee Road and Suwanee Avenue including 212 and 220 Suwanee Avenue and contains approximately 3.06 acres. The Planning Department recommends approval with conditions. Mr. Josh Campbell stated that the applicant has requested a postponement of one month to work on refining a proposal.

<u>Dondra Golden, 284 Seminole Circle</u> – Ms. Golden noted that she also owns the property at 218 Seminole Circle. Ms. Golden spoke in opposition to this request stating concerns for the environment, wildlife, and potential increased traffic and parking congestion.

L. Authorize Mayor to Enter into a Service Agreement with IPR for On-Demand and Stormwater Repair

Staff requests entering into a service agreement that would allow IPR to repair stormwater systems identified by the city as a high priority. IPR has agreed to price all repairs based upon piggybacking the City of Dunwoody contract, which was awarded to IPR based on a low bid for stormwater repairs.

M. Authorize Mayor to Enter into a Project Framework Agreement with Georgia DOT The city obtained federal funds for the engineering of projects from the Loop Study. To begin this project, the city is required to enter into a Project Framework Agreement with the Georgia Department of Transportation.

N. Authorize Mayor to Enter into an Agreement with Dimensional Designs for Town Center Parklets – \$56,941.68

Dimensional Designs will be building and installing two parklets in the parking spaces in front of the shops in Suwanee Town Center. Each parklet will take up two parking spaces. The location of the parklets will be in front of Pulse Nails, and in between Cafe Amico and Golden Seven. The cost for the two parklets is \$56,941.68.

Motion to approve by Councilmember Hilscher, second by Councilmember Miller and so carried 5-0.

## O. Consider Purchase of Town Center Parking Directional Signage from Big Mouth Signs

As part of the current budget, Town Center public parking signage is being finalized. This will make it easier for visitors and residents to be aware of the parking areas in and around Town Center, including the parking deck behind Siena. The budget for the project is \$80,000.

Motion to approve by Councilmember Charpentier, second by Councilmember Hilscher and so carried 5-0.

# P. Authorize Mayor to enter into an agreement with the Dickerson Group for Stormwater Repair

Councilmember Hilscher motioned to authorize the Mayor to enter into an agreement with the Dickerson Group in the amount of \$772,205.00 for stormwater repairs, second by Councilmember Hall and so carried 5-0.
