# 1. RZ-2022-004 – Owners: 3805 317 LLC and Franklin Property Group LLC. Applicant: Walker Anderson Homes

(This item was postponed at August 23, 2022, and September 27, 2022, Council Meetings). The applicant requests a rezoning from R-100 (Residential Single-Family District) to RM-8 (Residential Multi-Family Duplex District) to allow for 20 townhome units. The site is located at the southeast corner of Lawrenceville-Suwanee Road and Suwanee Avenue including 212 and 220 Suwanee Avenue and contains approximately 3.06 acres. The Planning Commission and Planning Department recommended approval with conditions.

Mr. Josh Campbell reiterated the original request from R-100 to RM-8, and stated that the applicant has subsequently modified the plan to 7 single-family detached units. Mr. Campbell noted if the City Council chooses to approve the modified plan, he recommended approving it as IRD with the set of conditions dated October 25, 2022.

The applicant, Mr. Corbitt Woods, 390 Brogden Road, stated that he has adjusted the plan, which he feels compliments Suwanee Avenue. Edits that were made include having two lots facing Lawrenceville-Suwanee Road. Mr. Woods additionally noted that the development will be on sewer, not septic.
