A. Amended Alcohol Beverage License for Chef JK, LLC dba Choi's Grill, 1500 Peachtree Industrial Boulevard, Suite 190

Chef JK, LLC has applied to amend the alcohol license to add on-premise consumption of distilled spirits. Phoebe Han has applied to be the licensee. The Business Services

Department recommends approval. This item will appear on the February 28^h Council Public Hearing and Regular Agenda unless Council prefers otherwise.

B. Priority Stormwater Projects

Continuing the city's stormwater repair project, streets that are next for improvement are Landover Crossing, Morning Top Place, and Sharon Industrial Way. IPR is creating a scope of work and an estimate that will be discussed. Staff anticipates this item will appear on the <u>February 28th Council Regular Agenda</u> unless Council prefers otherwise.

C. Water System Improvement Report

As part of our IGA with Gwinnett County relating to the water system transfer, the County has committed to making certain financial investments to the system. They committed to at least \$500,000 in improvements over the next 10 years. We have received our first report on their activities, which indicates that they have spent about \$117,000 on inspections and capital improvements over the last year.

D. GMA Pension Plan Amendment

Pursuant to earlier workshop discussions, staff will present an amendment to the current GMA pension plan. Consideration of the amendment will appear on the <u>February 28th Council Regular Agenda</u> unless Council prefers otherwise.
