The Public Art Commission's selection committee recommends commissioning artist Michael Szabo to create a sculpture for the new veteran's memorial, to be located at Town Center on Main. This agreement is in the amount of \$200,000.00

## L. Authorize Mayor to Execute Required Documents for a GMA Pension Plan Amendment
