1. Alcohol Beverage License for Cow Wow Korean BBQ, 2850 Lawrenceville-Suwanee Road, Suite F

Mr. Josh J. Chung has applied for an alcohol beverage license for on-premise consumption of beer, wine, and distilled spirits for Cow Wow Korean BBQ, a full-service Korean barbeque restaurant to be located at 2850 Lawrenceville Suwanee Rd., Suite F. The Business Services Department recommends approval. A representative for the business addressed Council regarding the application.

J. Consider Authorizing the Purchase of a High-Pressure Stormwater Cleaner – \$88,789.26 To maintain the stormwater systems, staff is requesting to purchase a high-pressure stormwater cleaner. This equipment will allow for quick unclogging of storm pipes and inlets due to its ability to self-propel into a pipe with high pressure and water volume. The cost for the equipment is \$88,789.26.

N. Consent Agenda

1. Authorize Stormwater System Condition Assessment – \$80,000.00

To continue the city's stormwater project, approximately 30,000 linear feet of stormwater pipe must be assessed. The city's vendor, Integrated Science and Engineering (ISE) has submitted a scope of work with a cost of \$80,000.

2. Authorize the Mayor to Execute an Intergovernmental Agreement with Gwinnett County for Election Equipment

The city must enter into an intergovernmental agreement with Gwinnett County for the use of one Absentee Ballot Drop Box for the November 7th General Election.

3. Authorize the Mayor to Enter into Maintenance Agreements with Gwinnett County and Georgia Department of Transportation for the Gateway Median Project

To begin median enhancements in the Gateway area, the city must enter into an intergovernmental agreement with Gwinnett County and a right-of-way maintenance agreement with the Georgia Department of Transportation.
