A. Alcohol Beverage License Soo K-Chinese Cuisine, 3131 Lawrenceville-Suwanee Road, Suite C10

Soo K-Chinese Cuisine, a Korean/Chinese restaurant to be located at 3131 Lawrenceville-Suwanee Rd. Ste C10, has applied for an alcohol license for the onpremise consumption of beer, wine and distilled spirits. Mr. Chang Won Hong has applied to be the licensee. The Business Services Department recommends approval of the license. This item will be on the July 25th Council Public Hearing and Regular Agenda unless Council prefers otherwise.

B. Call of Election, Qualifying Dates, and Poll Official Compensation

Council must adopt a resolution to announce the general election to be held on November 7, 2023 and set qualifying dates and Poll Official compensation. This item will be on the <u>luly 25th Council Regular Agenda</u>.

C. Police Department Contract with Axon Enterprises, Inc. for Public Safety Equipment and Services – \$192,855.27

Staff is seeking approval to enter into a five-year contract with Axon Enterprises, Inc. for the purchase of and services for body cameras, dash cameras, and Tasers. The first-year contract amount is \$192,855.27, with a total five-year contract amount of \$995,032.13. This item will appear for consideration on the <u>July 25th Council Regular Agenda</u> unless Council prefers otherwise.
