1. SUP-2009-002: Request for Special Use Permit by WSILC, LLC to Construct a Free-standing Automated Teller Machine at 17 Satellite Boulevard

The applicant requests a Special Use Permit to allow for a free-standing ATM. The 0.43-acre site is located on Satellite Boulevard, just south of the intersection of Lawrenceville-Suwanee Road and Satellite Boulevard, in front of Wal-Mart. Staff and Planning Commission recommend approval with conditions.

Josh Campbell, Planning Director, presented the staff analysis as follows: The request is for a free standing Automatic Teller Machine at 17 Satellite Boulevard. Staff recommends approval with conditions. P&Z recommended approval 3-0 of the request. There were no questions from Council and no audience participation.

2. AMD-2009-005: Proposed Amendment to the City of Suwanee Zoning Ordinance to Modify Article V. Section 510 PMUD Planned Mixed Use District to Reduce the Minimum Required Site Area for the PMUD Zoning District.

One project on this year's STWP was for staff to evaluate the current PMUD ordinance.

Staff has completed this review and recommends reducing the minimum site area for PMUD developments from five acres to two acres. Staff drafted a proposed amendment to the Zoning Ordinance to reflect this recommendation. The Planning Commission recommends approval of the amendment.

Josh Campbell, Planning Director, presented the staff analysis as follows: PMUD currently requires 5 acres. The proposed Amendment will reduce the acreage to 2 acres. The 2030 Plan anticipates more redevelopment. There were no questions from Council and no audience participation.

3. Distilled Sprits License Application by American Ale House Grill & Tap

American Ale House Grill & Tap has applied for a distilled beverage license for their restaurant at 3463 Lawrenceville-Suwanee Road, Su. 100 & 101. The business currently has a beer & wine license for on-premise consumption.

Marty Allen, City Manager, stated this is a distilled license for an establishment in the former Beef 'O Brady's location. Applicant, Mickel Ayoub, 1693 Tappahannock Trail, Marietta, GA 30062, was present. There was no audience participation.

13. Authorize Mayor to Execute a Contract with Southeastern Engineering, Inc. in an Amount Not to Exceed \$42,700 for Professional Design and Construction Management Services for the Buford Highway/White Street Farm Property

Staff released an RFQ for the design and construction management services of the community garden and received 15 proposals. A staff committee reviewed them for conformance with the RFQ, quality of proposed services, firm reputation, cost, etc. The cost proposals for the top-seven-ranked firms were opened and the prices ranged from \$35,000 to \$115,591. The proposal submitted by Southeastern Engineering, Inc. (SEI) was ranked highest by staff and their cost was the second lowest. Staff met with the team, checked references for past projects and recommends awarding the contract to SEI. The team they have put together has extensive community garden/farming experience and includes nationally recognized organic farmer, Farmer D.

Motion by Councilmember Brooks to authorize the Mayor to execute a contract with Southeastern Engineering, Inc., in an amount not to exceed \$42,700 for Professional Design and Construction Management Services for the Buford Highway/White Street Farm Property, second by Councilmember Foster and so carried 5-0.

14. Consent Agenda

A. Authorize Mayor to Execute Contract with Core Aerations, LLC dba Level Lawns in the Amount of \$13,974 for Core Aeration and Top Dressing Services for Town Center Park

Staff released a bid for core aeration and top dressing services for the Town Center Park and Town Center Avenue medians and lawn areas. The project generally consists of work needed to provide for a healthier and more level lawn area for Town Center Park. Funding for this work is included in the Public Works Department FY 2009 operating budget. Staff recommends awarding the bid to

the second lowest bidder, based on their responsiveness to the bid specifications.

B. Adoption of Resolution in Support of the City's Application to GEFA for a Drinking Water Loan in an Amount Not to Exceed \$488,044

In order to submit a Drinking Water Loan application to GEFA, Council must adopt a resolution of support. This \$488,044 loan will fund improvements to the Water System, as detailed in past workshops. The ARRA is subsidizing the repayment of these loans; Suwanee will receive a 40% subsidy of \$192,018. This will make the total repayment amount \$288,026, payable over 20 years at a 3% interest rate. The City will also pay loan origination fees of 2% of the total loan, or \$9,600.88. At the April 28 Council meeting, Council authorized Rindt McDuff to complete the design work necessary to bid and construct these projects, therefore making them "shovel ready".

C. Consider a Resolution to Change the Location of the City of Suwanee Municipal Election Polling Place from Suwanee Crossroads Center to Suwanee City Hall

A resolution is needed to obtain pre-clearance from the Department of Justice to change the Suwanee voting precinct from the Crossroads Center to City Hall. This will allow the November election to take place at City Hall. Once pre-clearance is obtained, the information will be forwarded to Gwinnett County Elections.

Motion by Councilmember Brooks to approve the Consent Agenda, second by Councilmember McOmber and so carried 5-0.
