Motion by Councilmember Foster to certify the election results, second by Councilmember Brooks and so carried 4-0.

C. Swearing-In of Newly Elected Councilmember Dick Goodman

Gregory Jay performed the swearing in ceremony for newly elected Councilmember Dick Goodman.

D. Consider Amendment to the Environmentally Preferable Purchasing Policy

The City has applied for certification through the ARC Green Communities Initiative. ARC has reviewed the City's application and directed the City to amend its Environmentally Preferable Purchasing Policy, specifically as it relates to construction of new government buildings.

Motion by Councilmember McOmber to adopt the Amendment to the Environmentally Preferable Purchasing Policy, second by Councilmember Goodman and so carried 4-0.

Mayor Williams stated this is a policy approved earlier in the year. The amendment is for administrative clean-up.

E. Consider Adoption of the Complete Streets Policy

This is another policy related to the Green Communities certification. While ARC supports the City's planning policies as they related to promoting use by pedestrians, cyclists, etc., they requested that we adopt an official Complete Streets policy.

Motion by Councilmember Brooks to adopt the Complete Streets Policy, second by Councilmember Foster and so carried 4-0.
