B. Ownership Change: New Licensee for Monterrey Mexican Restaurant, 1000 Peachtree Industrial Blvd

Monterrey Mexican Restaurant, located at 1000 Peachtree Industrial Blvd., has changed ownership. Ms. Mary Oviedo has applied for a license for the on-premise consumption of beer, wine, and distilled spirits. The Business Services department recommends approval.

C. Amended Alcohol Beverage License for Bonbon Chicken & Pizza, 3131 Lawrenceville Suwanee Rd, Ste A6

Bonbon Chicken & Pizza, located at 3131 Lawrenceville Suwanee Rd., Ste A6, has applied to add distilled spirits to the beer and wine on-premise license that they already have. The Business Services Department recommends approval.
