City Council Informal Session

Informal discussion among City Councilmembers and staff. Food provided for Elected Officials and staff. No action to be taken during session.

6:30 P.M. PUBLIC HEARING

Mayor Williams called the meeting to order at 6:33 P.M. and read the Procedures for Public Hearings for the record.

1. Community Agenda of the 2030 Comprehensive Plan

Josh Campbell, Planning Division Director, stated this is a required public hearing in order to transmit the Comprehensive Plan to DCA and ARC for regional review. The transmittal resolution is scheduled for the May 27 Council meeting. John Skach and Bob Beagle of Urban Collage provided an update of the Comprehensive Plan process and highlights of specific portions of the Plan. Mr. Beagle thanked the members of the audience who were participants in the process. Mayor Williams thanked the media for informing the public on the process. He also thanked Urban Collage for their efforts in taking the raw data and instilling it into the document. There was no audience participation.

2. SUP-2008-004 - Applicant: Barry W. Coker. Owner: Jose L. Pombo. Requests a special use permit to allow for an addition to an existing automotive service establishment. The site is located in Land Lot 251 of the 7th District along Peachtree Industrial Boulevard north of Silver Peak Parkway and contains approximately 2.00 acres.

Staff recommended approval with conditions. The Planning Commission voted 3-2 to approve with staff-recommended conditions.

Josh Campbell, Planning Director presented the staff analysis as follows: The applicant seeks a special use permit on an approximately 2.00-acre tract for a building addition to allow for a 2,500 square foot building addition to an existing 6,250 square foot building that houses an automobile repair business. The subject property also contains a landscape business with a small 240 square foot building, a 5,000 square foot building used for automotive repair, and a cell tower.

The subject property is zoned C-2. When the property was developed automotive service establishments were permitted uses in the C-2 District. In 2001, the City amended the Zoning Ordinance to include automotive service establishments as special uses. Therefore, the site is a legal non-conforming site. In order to accomplish this expansion, the owner will need a Special Use Permit.

The Special Use Permit process was created by the City Council in 2001 to better handle certain land uses. The SUP process allows the Council to review certain proposals in the context of their use and take into consideration the surrounding area and other relevant factors. In this case the specified use would allow for a building addition to an automotive service establishment.

The site is a developed parcel with two existing buildings, one modular office, and a cell tower. There is adequate space for a small addition to the existing automotive facility.

The site is located on Peachtree Industrial Boulevard. The future land use plan recommends retail and commercial uses for the location. The existing commercial zoning of the property is consistent with this designation; however, the plan also recommends steering automotive uses away from residential areas.

The applicant states that the site has been used for automotive repair since development in 1989 and the use will not change with approval of the Special Use Permit.

The applicant states that the new addition will match the existing building front and the appearance on the site from Peachtree Industrial Boulevard. The building addition will allow the tenant to expand the auto service business with an additional service bay in the rear of the building. The property owner also intends to relocate an

existing landscape company's modular office located at the southern end of the building to a location behind the building addition in order to shield it from the street.

In conclusion, approval of the request could be appropriate. While the existing use is inconsistent with the Future Land Use Plan's recommendation to locate automotive related uses away from residential areas the expansion is fairly minor and should result in minor improvements to the site. Therefore, the Planning Department recommends approval with conditions of SUP-2008-004. The Planning Commission recommended approval with staff conditions to include an additional condition to remove a fence to allow for additional connection between two existing driveways.

Support

Barry Coker, 1730 Bennett Road, Grayson, GA, represented the applicant. Mr. Coker stated the owner is in agreement with the recommended conditions. He stated an additional condition was recommended by the Planning Commission for inter-parcel access. Mr. Coker stated he is 100% in agreement with inter-parcel access but this does not apply in this case. The building addressed in this case has two businesses and a hobby shop area. The second driveway enters a landscape business. Opening up this drive will cause what appears to be a dangerous situation for the persons accessing the garage doors. The Commission voted in favor of the case with the addition of the condition to remove the fence. Two Commission members voted against the request and explained afterwards they were voting against removal of the fence.

Opposition – None.

7. Audience Participation

A. Consideration of Award of Contract to Henry Graphics, Inc. for Suwanee Welcome Sign Package and Execution of Contract by Mayor

The City received three bids for the manufacturing and installation of these custom signs. Staff has reviewed the bids and recommends awarding the contract to the low bidder, Henry Graphics, Inc., for \$46,106.

Motion to award contract to Henry Graphics, Inc., for Suwanee Welcome Sign Package and authorize Mayor to sign by Mayor Pro Tem Burnette, second by Councilmember McOmber and so carried 5-0.

F. Authorize Mayor to Execute Change Order for Redesign of New City Hall First Floor

Change order to modify the first floor layout to create a central corridor and modify the Planning public counter/waiting area.

G. Authorize Mayor to Execute Change Order for Redesign of New City Hall Second Floor

Change order to modify the layout of the second floor conference room, Greenway Library, staff break room and waiting area.

H. Authorize Mayor to Execute Easement Documents with Georgia Power for Sims Lake Park

Execution of easement documents to provide power service to Sims Lake Park.

I. Authorize Mayor to Execute Application for a HEAT Grant from the Governor's Office of Highway Safety

Per discussion at the April 17 workshop, Marty Allen and Chief Jones wish to evaluate the benefits of applying for a HEAT Grant. Should they decide to

apply, the Mayor will be authorized to execute the necessary application documents.

Motion to approve the Consent Agenda by Councilmember Brooks, second by Councilmember Rispin and so carried 5-0.

11. City Manager's Report

- Sims Lake Park is under construction and everything is going well. Early summer opening is the goal.
- Water system focus group established and meetings are underway.
- Mayor Williams inquired about the committee designated to address traffic concerns in Chattahoochee Run subdivision. Mr. Allen stated a meeting has been scheduled for May 8th. There have been delays in getting the group together due to changes in the HOA presidency.
