CITY COUNCIL MEETING TUESDAY, JANUARY 23, 2024

A. Call to Order

Mayor Burnette called the meeting to order at 6:35 p.m.

B. Oath of Office

Mr. Gregory Jay, City Attorney, performed the ceremonial oath of office for Mayor Jimmy Burnette, Councilmember Julianna McConnell (Post 1), and Councilmember Larry Pettiford (Post 2).

C. Adoption of Rules and Procedures

In accordance with Section 2.19 of the City Charter, the City Council shall each year adopt its rules of procedure and order of business. Staff recommends adopting the current edition of Robert's Rules of Order.

Motion to adopt by Mayor Pro Tempore Miller, second by Councilmember Pettiford and so carrier 5-0.

D. Selection of Mayor Pro Tempore

In accordance with Section 2.27 of the City Charter, by a majority of vote, the City Council shall elect a Councilmember to serve as Mayor Pro Tempore for that ensuing year. The Mayor Pro Tempore shall assume duties and powers of the Mayor during the Mayor's disability or absence.

Mayor Pro Tempore Miller motioned to select Councilmember Hilscher as the Mayor Pro Tempore for 2024, second by Councilmember Pettiford and so carrier 5-0.

E. Public Hearing

1. Alcohol Beverage License Ownership Change – New Licensee for Monterrey Mexican Restaurant, 1000 Peachtree Industrial Boulevard

Monterrey Mexican Restaurant, located at 1000 Peachtree Industrial Blvd., has changed ownership. Ms. Mary Oviedo has applied for a license for the on-premise consumption of beer, wine, and distilled spirits. The Business Services department recommends approval. There were no comments.

2. Amended Alcohol Beverage License for Bonbon Chicken & Pizza, 3131 Lawrenceville Suwanee Rd, Suite A6

Bonbon Chicken & Pizza, located at 3131 Lawrenceville Suwanee Rd., Ste A6, has applied to add distilled spirits to the beer and wine on-premise license that they already have. The Business Services Department recommends approval. There were no comments.

3. SUP-2024-001 – Owner: Hanover 2021 Dynasty Trust. Applicant: BCB, LLC. The applicant requests a Special Use Permit to allow for an animal daycare facility with boarding and outdoor runs in the C-2A (Special Commercial District) zoning district. The site is located on Peachtree Industrial Boulevard south of Tench Road and contains approximately 1.4 acres.

The representative for the applicant, Melody Gloutin of Anderson, Tate, and Carr at 1960 Satellite Boulevard, Duluth, presented the request to Council. Ms. Gloutin highlighted that the application seeks approval for utilizing approximately 11,280 square feet of an existing building as well as outdoor areas to establish a luxury pet daycare and boarding facility under the brand name Canine Resorts, noted as a highend facility. If approved, this would mark the first Canine Resorts franchise in Georgia. Ms. Gloutin mentioned that the facility will undergo updates and construction incorporating features and materials aimed at providing effective buffering for both sight and noise.

Thomas McConnell, Jr. 3795 Smithtown Road, expressed safety concerns regarding security of the animals, particularly in relation to the busy Peachtree Industrial Boulevard area. He wanted to be sure there was implementation of safety protocols for the well-being of both animals and drivers.

In response to Mr. McConnell's concerns, Ms. Gloutin explained the presence of secure outdoor fencing and a structurally sound indoor environment, ensuring a safe environment for both animals and those in the vicinity.
