Mayor Burnette called the meeting to order at 6:32 p.m.

B. Announcements

- 1. Applications are now being accepted for the 2024-2025 Suwanee Youth Leader program. This award-winning nine-month leadership program is open to Freshman and Sophomores who live in the North Gwinnett, Peachtree Ridge, and Collins Hill clusters, as well as home school and private school students who reside within those clusters. H. Authorize the Purchase of 5 Police Vehicles

Authorize the purchase of four police vehicles on state contract and one electric vehicle subject to city bidding procedures.

K. Authorize Mayor to Execute Contract with On-Demand Service Provider Peach State Construction for Suwanee Dam Sidewalk Gap Project - \$325,000

Peach State Construction has quoted an anticipated cost of \$291,000, with an optional additional \$34,000 allocated for supplementary project scope work, along with a 20% contingency.

Councilmember Miller motioned to authorize, second by Mayor Pro Tempore Hilscher and so carried 6-0.

L. Authorize Mayor to Execute Contract with Professional Probation Services (PPS)

The current PPS contract is due for renewal with an initial term of one year, followed by the option for four consecutive one-year renewals. Staff recommends renewing this contract.

Councilmember Pettiford motioned to authorize, second by Councilmember Charpentier and so carried 6-0.

M. Consider Surplus Sale Items
