Due to recent staffing changes, staff is planning to restructure the reporting of municipal court staff to fall under the City Clerk's office. More details will be discussed during the workshop.

E. Greenway Trail Audit

Staff is preparing to perform a comprehensive review of our greenways to uncover deficiencies and areas to improve. Staff will provide more information.
