6. Special Presentations

A. Don Schwarz of the Georgia Native Plant Society

Mayor Pro Tem Landers and Council Member Hassell presented a proclamation to Mr. Schwarz recognizing him for his efforts in coordinating the plant rescue project at the Town Center Park site. August 20, 2003 was proclaimed "Don Schwarz Day".

Mr. Schwarz stated the plant rescue project was very natural for him to do. He acknowledged other members of the plant rescue team who were in the audience.

B. Mark Tibbetts and the Tibs Group

Mayor Pro Tem Landers presented Mr. Tibbets a Certificate of Recognition. Mr. Tibbetts was named Small Business Person of the year 2003 by Gwinnett Chamber of Commerce.

C. Christopher Hansard

9. NEW BUSINESS

A. Consideration of an Ordinance to Regulate and Provide for the Calling of the General Municipal Election on Tuesday, November 4, 2003

This ordinance calls for the General Municipal Election to be held on November 4, 2003 to fill the expired terms of Mayor, Post 1 and Post 2. It establishes the qualifying dates for candidates of September 8 through September 12. The qualifying fee for Mayor is \$180 and for Councilmembers is \$108. The ordinance also establishes compensation for poll workers at \$185 for Poll Manager, \$95 for Assistant Poll Manager, and \$90 for Poll Worker. A copy of the ordinance is included in your packet. ACTION: Consider the ordinance.

Motion to adopt Ordinance to Regulate and Provide for the Calling of the General Municipal Election on Tuesday, November 4, 2003 by Councilmember Burnette, second by Councilmember Hassell and so carried 5-0.

B. Consideration of the Issuance of an Alcohol License: Mi Casa Mexican Restaurant. Applicants: Delia and Juan Manuel Aguirre.

Hardin Watkins stated Mi Casa Mexican Restaurant, located at 2855 Lawrenceville-Suwanee Road (Horizon Village Shopping Center/Publix), has applied for an alcohol license for beer, wine, and distilled spirits to be consumed on the premises. Delia Aguirre and Juan Manuel Aguirre will be the licensees. Both the GBI and the FBI prints have been returned with no problems. Staff recommends approval. ACTION: Consider issuing the alcohol license.

C. Consideration of a Resolution to Amend the Agreement Between the City of Suwanee and Crescent Resources, Inc.

Hardin Watkins stated representatives from Crescent Resources attended the May Workshop to present their building plans for the de-annexed land in River Club. They are seeking Council approval to proceed. A copy of their proposed amendment to the de-annexation agreement is included in your packet with the resolution. ACTION: Consider the resolution.

Motion to approve Resolution to Amend the Agreement Between the City of Suwanee and Crescent Resources, Inc. by Councilmember Rispin second by Councilmember Burnette and so carried 5-0.

D. Authorization for the Mayor to Enter into Agreement with Georgia Department of Transportation for the Pedestrian Underpass

Hardin Watkins stated the contract from the Department of Transportation to proceed with the pedestrian underpass project. The underpass would be located behind the current City Hall building to allow pedestrian access between Historic Downtown and the present City Hall complex and access to Town Center Parks. This is a \$904,000 grant from GA DOT. This agreement will allow the City to formally accept these funds. A 20% match will be required. There will be a 3-5 year window.

Mayor Pro Tem Landers stated this project was included in the Master Plan to draw these two areas together. plans for the Town Center Park.

ACTION: Consider authorizing the Mayor to enter into agreement with Georgia DOT.

Motion to authorize Mayor to Enter into Agreement with Georgia Department of Transportation for the Pedestrian Underpass by Councilmember Brooks second by Councilmember Hassell and so carried 5-0.

E. Consideration of Approval of a Quit Claim Deed to the Maple Ridge Subdivision's Recreation Area

Gregory Jay stated the Maple Ridge Homeowner's Association is trying to secure another loan to make improvements to their recreation area. The original developer deeded this property to the City of Suwanee. To secure the loan, the HOA needs the City to subordinate its position on the property. This same request was made of the City about 15 years ago when the HOA secured their first loan. The HOA is requesting that the City quit claim it's interest in the property to the benefit of both parties. ACTION: Consider the resolution.

Motion to approve a Quit Claim Deed to the Maple Ridge Subdivision's Recreation Area by Councilmember Brooks second by Councilmember Burnette and so carried 5-0.

F. Consideration of Approval of Budget Adjustments

Hardin Watkins stated there are three budget adjustments for consideration. The first is to establish a fund for the Settles Point Road culvert rehabilitation project. The second is to establish a fund for the Better Parks Campaign. The revenue will be generated from the various fundraising efforts. The third adjustment is to the Open Space Fund to provide funds for paying Gwinnett County taxes on the DeLay, Hewell, and Hovendick properties; to make funds available for the Rivermoore closing; and to reclassify funds for the dam improvements. ACTION: Consider the budget adjustments.

Motion to approve Budget Adjustments by Councilmember Hassell second by Councilmember Burnette and so carried 5-0.
