Mayor Masino opened the Public Hearing at 6:35 P.M. Hardin Watkins, City Manager, read the procedures for Public Meetings.

1. RZ-2004-011 & SUP-2004-004 - Applicant: John A. Buonomia. Owner: Metal Building Assoc. Inc. Requests rezoning from M-1 (Light Industry District) to C-2 (General Commercial District) to allow for an automotive repair facility. The site is located in Land Lot 211 of the 7th District at 3600 Lawrenceville-Suwanee Road south of Sharon Industrial Way and contains approximately 1.00 acres.

Marty Allen presented the staff analysis as follows: The applicant requests rezoning of 1 acre out of a roughly 2+ acre parcel from M-1 (Light Industry District) to C-2 (General Commercial District) with a Special Use Permit to allow for an automotive repair facility. The site is located on Lawrenceville-Suwanee Road west of Sharon Industrial Way. The applicant proposes to conduct services ranging from complete mechanical rebuilds and restorations of automotive vehicles to oil changes and emissions testing.

The entire property contains two metal buildings, one of which is approximately 7,500 square feet. The applicant is requesting the rezoning and special use permit for the westernmost building on the site. The building formerly contained a grading and hauling operation.

The subject building includes two existing bay doors along the north side of the building. The applicant proposes to remove the bay doors on the side of the building or not use these doors and provide a single vehicular access point into the rear of the building.

The subject property is surrounded by a mixture of well-established commercial and light-industrial uses. To the north and west of the subject area are a number of light industrial uses including automotive related uses such body shops (zoned M-1). To the south of the subject property is a small shopping center (zoned C-2). To the west of the subject property, across Lawrenceville-Suwanee Road, are a number of commercial uses (zoned C-2). Given the type of existing uses in the area, the proposed use would be consistent the uses in the area.

The City's Future Land Use Plan recommends commercial uses for this site. The proposed use of the site for automotive service is consistent with this designation. Last year, the City approved an amendment to the comprehensive plan which recommended moving automotive related uses away from more residential areas and towards more heavily commercial areas. Given the significant amount of commercial uses and industrial uses in the area, the applicant's proposal is generally consistent with the Future Land Use Plan.

In conclusion, the requested rezoning from M-1 to C-2 with Special Use Permit to allow for an automotive service is consistent with the intent of the Comprehensive Plan and existing uses in the area. Therefore, the Planning Department recommends approval with conditions of RZ-2004-011 and SUP-2004-004. The Planning Commission reviewed the case at the December meeting and also recommended approval with conditions of the request. The Commission recommended condition changes as outlined in the Council packet.

Richard Carothers, 5171 Edgerton Drive, Norcross, GA 30092, represented the applicant. Mr. Carothers stated that Mr. Buonomia is an excellent mechanic and would be an excellent corporate citizen. The applicant has been in business over twenty-five years. He spent five to six years in England in trade school learning the trade. The applicant plans to paint the building. The bay doors will not be seen from the approach. Parking is scheduled to be in the rear. Landscaping is recommended. The environmental issues will be addressed (i.e., oil containment). This particular building does not have floor drains. Even if there is a spill, he has the equipment to contain the spill. The mops, etc. used in clean up are picked up by a service.

John Buonomia, 471 Shore Drive, Suwanee, GA 30024, stated there is a fence in the rear of the building for privacy. All work will be performed inside the building.

Mayor Masino asked if the other shop will be closed and move to Suwanee. Mr. Buonomia stated yes. He only has one shop and it will be closed and relocated to Suwanee.

Mayor Pro Tem Hassell asked Mr. Buonomia if he specialized in a particular type vehicle. Mr. Buonomia stated yes. He specializes in imports. He stated that he works on imports and domestic vehicles. The breakdown of specialty of work is electronics, drivability and emissions repair. He stated he has maintained a 100% "fix right the first time" with the Georgia Clean Air Force.

There was no opposition to the case.

The Public Hearing closed at 6:45 P.M.

 - A. RZ-2004-011 & SUP-2004-004 Applicant: John A. Buonomia. Owner: Metal Building Assoc. Inc. Requests rezoning from M-1 (Light Industry District) to C-2 (General Commercial District) to allow for an automotive repair facility. As discussed at the December Workshop, staff has proposed two adjustments to the general fund, adjustments to four capital project funds and created one new capital project fund. To produce events for FY 04-05, Planning and Community Development is requesting \$39,966 in funding. \$52,000 was budgeted for the I-85 Business District Study. The selected consultant's bid came in at \$68,500 so staff is requesting an adjustment for the difference. Adjustments were made to the Suwanee Greenway Project Fund to reflect actual receipts and expenditures and to appropriate funds for the sign package. Adjustments were made to the URA Town Center Project Fund to account for estimated revenues for the sale of URA land. Adjustments were made to the Open/Green Space Project Fund to reflect actual expenditures, including signage, as well as appropriations for dam repairs and master planning of the Hewell property. Adjustments were made to the Water Fund to account for the increased GEFA loan amount of \$119,000. The new capital project fund was created as Town Center Facility Improvements to account for new city facilities at Town Center. Amie is proposing transferring \$31,990 from reserved fund balance to unreserved fund balance to cover the cost of a space needs assessment. ACTION: Consider approval of the budget adjustments.

Motion by Councilmember Brooks to approve the Budget Adjustments, second by Councilmember Burnette and so carried 6-0.

C. Consideration of Approval of Real Property Donations

Motion by Mayor Pro Tem Hassell to approve Real Property Donations representing undivided interests of David Bowen, David Beard, Keith Breedlove and David Breedlove in 49 acres adjacent to Suwanee Creek, second by Councilmember Brooks and so carried 6-0.

Gwinnett County performs enforcement activities on the City's behalf. They would like modifications to make the City's ordinance the same as the County's ordinance. ACTION: Consider adoption of the ordinance.

Gregory Jay has drafted a Tattoo ordinance to outline licensing requirements and regulations for such establishments. ACTION: Consider adoption of the ordinance.

E. Authorization for the Mayor to Amend the Agreement with J-Squared, Inc. for the Old Town Sanitary Sewer Project

Repair work was needed on a portion of the sewer line along Main Street due to poor installation. The City had an agreement with Rick Porter that he would make the needed repairs and the City would share the cost. The work has been completed for \$36,836.05 and the City's share is \$15,000. ACTION: Consider authorizing the Mayor to amend the agreement with J-Squared, Inc. for the Old Town sanitary sewer project.

Motion by Councilmember Brooks to approve the Consent Agenda, second by Councilmember Burnette and so carried 6-0.
