#### A. Call to Order

Mayor Burnette called the meeting to order and read the Procedures for Public Hearings for the record.

#### B. Public Hearing

## 1. Alcohol Beverage License – Famous Toastery

Famous Toastery is opening and has applied for a license to sell beer, wine, and distilled spirits at 1120 Peachtree Industrial. Blvd, Ste. 214. Ms. Carisse Moody is the applicant. The Business Services department recommends approval of the license.

2. RZ-2017-004 – Owner: Kuang Hu Chien. Applicant: HomeSouth Communities. Rezoning from C-2 (General Commercial District) to PMUD

(Planned Mixed-Use Development) to allow for townhomes. The site is located in Land Lot 251 of the 7th District at the northwest corner of the intersection of Peachtree Industrial Boulevard and Village Crest Drive and contains approximately 7.3 acres

3. RZ-2017-005 – Owner: Kuang Hu Chien. Applicant: HomeSouth Communities. Rezoning from C-2 (General Commercial District) to PMUD (Planned Mixed-Use Development) to allow for townhomes. The site is located in Land Lot 251 of the 7th District at the northeast corner of the intersection of Peachtree Industrial Boulevard and Village Crest Drive and contains approximately 7.6 acres

Item #2 & #3 were addressed at the same time. Josh Campbell, Planning Director, stated the Planning Commission, at the July meeting, postponed these items to the August 7, 2017 Planning Commission Meeting.

# **Opposition**

- Joe Rajano, 4349 Stoneridge. Mr. Rajano addressed concerns with not having enough information regarding the rezoning. Negatives include concern of increased traffic, no amenities, impact on schools and the plan today does not look like the City of Suwanee. Mr. Rajana shared concern regarding construction changes. He stated he has spoken with the developer.
- Harry Radcliff, 800 Village Manor Place (Village Grove). Mr. Radcliff express opposition to the proposal. The proposal has high density and does not offer green space, minimal buffer zones and no amenities. Village Grove will be depressed by the change to the rear of the subdivision. He is not in agreement with on street parking. Village Grove has rear loading townhomes. This development has front loading townhomes.
- Jeff Sundermeyer, 799 Rocky Peak Drive. General concensus of community in disagreement of this proposal. 143 more homes doesn't make sense. Everyone needs to work together for a development that works.
- Helen Chang, 897 Village Manor Place. Mrs. Chang stated her house is directly impacted by the proposed development. Her back yard with quiet trees will be impacted. She stated she has lived here for 3 years and chose this area because of the excellent reputation. To develop the area in the

way proposed, afraid this will adversely impact the quality of life for the Village Grove area.

- Joe Coty, 4916 Gathering Place. Referenced email recently sent to Council referencing the Commerce Plan which shows that housing under construction is in excess of housing demand. He stated PMUD is a poor reflection of the development proposed.
- Marietta Tontillo, 502 Village Arbor Park (Village Grove). She stated agreement with the previous speakers in opposition to the proposal. She and her husband moved to Suwanee to be near her son 10 years ago. They were fortunate to find Village Grove and affordable housing. There is not a need in Suwanee for more townhomes. When she moved in the tract near them was zoned commercial and they were excited to be able to have retail shops near them. This proposal is devastating to the area.
