#### A. Call to Order

Mayor Burnette called the meeting to order at 6:32 P.M., and read the procedures for Public Hearings for the record.

## **B.** Public Hearing

1. RZ 2017-008 – Owner: Halifax Enterprises, LLC. Applicant: Corridor Development, Inc. The applicant requests a rezoning from C-2 (General Commercial) to RM-8 (Residential Multi-Family Duplex District) to allow for townhomes. The site is located in Land Lot 237 of the 7th District at 760 Peachtree Industrial Boulevard and contains approximately 6.1 acres

Josh Campbell, Planning Director, presented the staff analysis as follows: This case has been on the agenda since August. The Applicant desires to rezone the property to RM-8 to allow for 49 townhomes. Staff and the Planning Commission recommends approval with conditions. Mr. Campbell stated if

Council desires to approve this request it is recommended use of conditions dated 11/9/2017.

## Support:

Shaun Adams, Anderson, Tate & Carr, 1960 Satellite Boulevard, Duluth, GA. The applicant requests approval to develop a small townhome community. The community will include greenspace and sidewalks to create a main street charm. The development will serve as a transitional development and create interparcel connectivity. Right in – right out access proposed in compliance with 2030 Comprehensive Plan and connectivity between Peachtree Industrial Boulevard and Eva Kennedy Road. Landscaping to enhance entry point.

Councilmember Foster inquired about easements along Peachtree Industrial Boulevard for landscape and sidewalks.

Mr. Matt Retter, 246 North Perry Street, Lawrenceville, stated approximately 42 feet of width with approximately 8 feet behind the curb line is owned by the applicant.
