1. RZ 2017-008 – Owner: Halifax Enterprises, LLC. Applicant: Corridor Development, Inc. The applicant requests a rezoning from C-2 (General Commercial) to RM-8 (Residential Multi-Family Duplex District) to allow for townhomes. The site is located in Land Lot 237 of the 7th District at 760 Peachtree Industrial Boulevard and contains approximately 6.1 acres

Due to ongoing water leaks of the City Hall roof and window front curtain, a consultant has studied and prepared a report with recommended repairs. Based on bids received, staff recommends awarding this contract to Everclear Enterprises, Inc. of Atlanta in the amount of approximately \$54,950.

Staff is currently reviewing bids for construction of sidewalks on Stonecypher Road and a path between George Pierce Park and Ruby Forest subdivision.

Motion to approve a Task Order with PeachState Construction for sidewalks on Stonecyper Road and a path between George Pierce Park and Ruby Forest subdivision, by Councilmember Foster, second by Councilmember Hilscher and so carried 4-0-2 (Burnette and Ireland abstained).

1. Approve Municipal Court Fee Revisions

Due to recent changes in state law, staff recommends changes to the fees associated with Failure to Appear, Contempt Fee, and Warrants.

2. Approve Budget Adjustment for Buford Highway Reconstruction Project Georgia DOT has received the bids for the Buford Highway reconstruction project. The bids were higher than the original GDOT pre-bid estimates, which requires an additional contribution from the City to fully fund the project. Staff recommends increasing the initial project budget by \$1.5 million, approximately \$1.1 million for construction and \$400,000 for contingency, using the Master Plan Implementation fund for this.

3. Approve 2017 SPLOST Intergovernmental Agreements

The County has forwarded two intergovernmental agreements that need to be adopted by the City concerning the city-managed and county-managed projects that are part of the 2017 SPLOST program.
